## STATEMENT OF CHARGE ACCOUNT TERMS AND CONDITIONS

Unless other arrangements are agreed to in writing, applicant agrees to pay the total balance due to Soiland Co., Inc. 30 days from the date of invoice. Some products include a courtesy discount of \$ .25/ton, which will be allowed if full payment is received by the 10<sup>th</sup> of the month following purchase. In the event full payment is not received timely, applicant agrees to pay interest of 1.5% per month, or the maximum rate of interest allowed by law, which ever is less. Credit will be suspended on accounts 45 days past due, and purchases will be allowed on a COD basis at the managers discretion of Soiland Co., Inc. until all past due amounts are paid in full. Any account may be closed at the discretion of Soiland Co., Inc. In the event legal action is undertaken to collect the account balance, Applicant agrees to pay reasonable attorneys' fees, and court costs incurred in collecting the account balance.

Applicant agrees to indemnify and hold Soiland Co., Inc. harmless from any claim of liability, which may arise from the use of goods and materials supplied by Soiland Co., Inc. Applicant authorizes Soiland Co., Inc. to request and release account information to project owners, construction lenders and contractors.
